**SUMMARY ANNUAL REPORT FOR THE
EMPLOYERS & OPERATING ENGINEERS
LOCAL 520 PENSION FUND**

This is the summary annual report for the EMPLOYERS & OPERATING ENGINEERS LOCAL 520 PENSION FUND, EIN 37-6053929, Plan number 001, for the period January 1, 2010 to December 31, 2010. This annual report has been filed with the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Total plan expenses were \$10,122,211. These included benefit payments of \$9,398,589, administrative expenses of \$723,622, and \$-0- in other expenses. A total of 1,944 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

Plan assets, after subtracting liabilities, totaled \$130,740,822 as of December 31, 2010 compared to \$111,931,100 as of January 1, 2010. During the year the plan experienced a change in its net assets of \$18,809,722. This change includes unrealized appreciation or depreciation in the value of plan assets; that is the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$28,931,933, which included employer contributions of \$19,771,995, penalties of \$75,258, a gain/ (loss) of \$1,835,461 from the sale of assets, \$3,637,623 in earnings from investments, unrealized appreciation/ (depreciation) in the fair value of investments of \$3,588,892 and \$22,704 of other income.
